AN ORDINANCE OF THE CITY OF HEMPSTEAD, TEXAS PROVIDING THAT THE CODE OF ORDINANCES OF THE CITY OF HEMPSTEAD BE AMENDED SO THAT PROPERTY DESCRIBED AS 5.0 ACRES, ISAAC DONOHO SURVEY, ABSTRACT A-121, TRACT 27-1; WEST 5.0 ACRES, ISAAC DONOHO SURVEY, ABSTRACT A-121, TRACT 27-2; 46.18 ACRES, ISAAC DONOHO SURVEY, ABSTRACT A-121, TRACT 27; 40.0 ACRES, ISAAC DONOHO SURVEY, ABSTRACT A-121, TRACT 29; 5.13 ACRES, JUSTO LIENDO SURVEY, ABSTRACT A-41, TRACT 11, IN WALLER COUNTY, TEXAS SHALL BE ZONED "HC — HIGHWAY COMMERCIAL" DISTRICT CLASSIFICATION; PROVIDING FOR PENALTIES; PROVIDING A SAVINGS CLAUSE; AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEMPSTEAD, TEXAS:

WHEREAS, the Planning and Zoning Commission has conducted a Public Hearing on December 7, 2015 at 5:30 P.M. on such request, in the time and manner required by law and the Zoning Ordinance of the City; and

WHEREAS, the City Council of the City conducted a Public Hearing on such request on December 21, 2015, at 6:00 P.M. in the time and manner required by law and the Zoning Ordinance of the City.

Section 1. The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct and are incorporated herein for all purposes.

<u>Section 2.</u> That the City of Hempstead Comprehensive Zoning Ordinance is amended as follows:

The Zoning Map is changed so that territory located in the City of Hempstead, Waller County, Texas as hereinafter described as:

- 1) 5.0 Acres, Isaac Donoho Survey, Abstract A-121, Tract 27-1
- 2) West 5.0 Acres, Isaac Donoho Survey, Abstract A-121, Tract 27-2
- 3) 46.18 Acres, Isaac Donoho Survey, Abstract A-121, Tract 27
- 4) 40.0 Acres, Isaac Donoho Survey, Abstract A-121, Tract 29
- 5) 5.13 Acres, Justo Liendo Survey, Abstract A-41, Tract 11

in Waller County, Texas shall be zoned HC – Highway Commercial Zoning district and the Zoning Map shall be amended accordingly.

<u>Section 3.</u> That a violation of this ordinance shall be a Class C misdemeanor and the penalty for violating this Ordinance shall be a maximum fine of \$2,000.00, and each day a violation exists shall be a separate offense.

Section 4. That if any provision of this Ordinance shall be held to be invalid or unconstitutional, the remainder of such ordinance shall continue in full force and effect the same as if such invalid or unconstitutional provision had never been a part hereof.

<u>Section 5.</u> That it is hereby officially found and determined that the meeting at which this Ordinance is passed is open to the public as required by law, and that public notice of the time, place and purpose of said meeting was given as required.

ORDINANCE NO. 15-116

AN ORDINANCE OF THE CITY OF HEMPSTEAD, **PROVIDING** TEXAS. **THAT** THE CODE OF ORDINANCES BE **AMENDED** BY **AMENDING** SECTION 2.19 "KEEPING LIVESTOCK WITHIN CITY LIMITS" OF CHAPTER 2 "ANIMAL CONTROL" TO REGULATE THE KEEPING OF FOWL WITHIN THE CITY LIMITS; PROVIDING FOR A PENALTY IN AN **AMOUNT UP TO \$2,000 A DAY AND CIVIL PENALTIES**

UP TO \$1,000 A DAY FOR A VIOLATION; PROVIDING AN EFFECTIVE DATE; PROVIDING A SAVINGS CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEMPSTEAD, TEXAS:

<u>Section 1.</u> That section 2.19 "Keeping Livestock within City limits" of Chapter 2 "Animal Control" of the Code of Ordinances of the City of Hempstead, Texas, is amended to read as follows:

DELETTIONS ADDITIONS

Section 2.19 Keeping Livestock and Fowl Within the City Limits

B. Keeping of Livestock and Fowl Prohibited

No person or other entity shall raise, keep, breed or maintain any livestock and/or fowl within the City of Hempstead.

B. Keeping of Livestock and Fowl.

No person or other entity shall raise, keep, breed or maintain any livestock within the City of Hempstead. No person or other entity shall raise, keep, breed or maintain any fowl within the City of Hempstead without first having complied with this section.

- (1) Restricted to Personal Noncommercial Use. No person or other entity shall raise, keep, breed or maintain any fowl on a tract of land within the city except for personal non-commercial use.
- (2) Number of Fowl and Containment. The number of fowl that will be permitted on a tract of land within the City is ten (10) chickens or other fowl. All chickens and other fowl shall be

maintained in closed pens and shall not be allowed to wander

about the premises.

Section 3. That a violation of this ordinance shall be a Class C

misdemeanor and may be fined up to \$2,000 for each day of violation as each

day a violation exists is a separate offense or the city may bring a civil action for

the enforcement of this article as provided by the Local Government Code,

Chapter 54, Subchapter B, and seek a civil penalty not to exceed one thousand

dollars \$1,000 per day or both.

<u>Section 4.</u> That if any provision of this Ordinance shall be held to be

invalid or unconstitutional, the remainder of such ordinance shall continue in full

force and effect the same as if such invalid or unconstitutional provision had

never been a part hereof.

Section 5. That this ordinance shall take effect January 1, 2016.
